We have stood shoulder-to-shoulder with members for the past five decades, as we have weathered the challenges of market cycles and unforeseen extraordinary events like the current pandemic.

At a local and state level, our branch and policy committees advocate to bring the issues of our industry to centre stage. Our 50th year typified the strength of our branch and policy network - and the willingness of our 450 volunteers to support the work of the Institute. The Institute has been a key voice in advocating on critical issues affecting our industry for 50 years. We have spent the year tirelessly championing your role as one of the economy's engines as well as the role we play in providing housing to the hundreds of thousands of new Queenslanders we're welcoming each year.

During 2021, a number of initiatives the Institute supported came to fruition such as the Growth Areas Team and the Institute's ongoing work to amend the definition of a storey to encourage more rooftop gardens in the urban landscape.

During the year, the Institute's Board recognised the dedication and contribution of some key members through the granting of five Distinguished Service Awards. The award honours those who act selflessly for the advancement of the property industry by

way of exceptional work on matters relevant to our members. Our five deserving recipients were Leanne Weekes (MinterEllison), Matthew Derrick (Norton Rose Fulbright), Graeme Bews (JFP Consultants), Bill Moorhead (Moorhead Family Communities), and Adam Gowlett (Kenfrost (1987).

During 2021 we refreshed our 11 policy committees and 12 branch committees as we do every two years. As two of our branches grew, we recognised the need to split Gold Coast and Logan in to standalone branches to better represent the unique needs of members in those regions, bringing up the total number of branches throughout Queensland to 12. We welcomed over 280 member volunteers to these committees who play an important role and underpin our advocacy work. We were delighted with the hundreds of nominations we received which demonstrates the eagerness of our members to contribute their voice, expertise, and time on industry issues.

The Institute's 50th year culminated in our Awards for Excellence, a wonderful opportunity for over 600 guests to celebrate the innovation in our industry and our leaders. Our Awards for Excellence is only possible with our judges who selflessly give up their time to contribute to industry leading program.

When a person or a project wins an award it's recognition from your peers and industry of an outstanding project.
