Our focus is to help build sustainable and vibrant communities for our growing state, and to contribute to planning and policy discussions which shape and preserve the way we live now and into the future.













PRESIDENT'S REPORT

2022 was the year that Brisbane learned to live with the COVID-19 virus.



It marked the year where Queensland's population grew by 2.1 percent, the highest of the states and territories, with 110,000 more residents and an estimated population of 5.4m people. What did not change was the strong demand for new buildings and the challenging environment in which buildings needed to be delivered.

Your collaborative support and commitment through contributions to submissions, member events, surveys, and the future of the property development industry has enabled us to achieve several milestones.

The 12-month extension to Development Approval timeframes, as well as a relaxation of 'close contact' definitions allowing more workers back on site sooner, was a significant achievement given the challenging conditions exacerbated by a combination of trade and supply shortages, floods, and COVID-19.

Acting on member reports that some customer's HomeBuilder applications were being rejected, the Institute advocated to Queensland Treasury and the Commonwealth Government, urging a review of the current interpretation of the definition of 'commencement'. As a result of our collective advocacy, the State approved the bulk of rejected applications.

Spanning across all our regional branches, dedicated and ongoing efforts to engage with Ergon Energy helped resolve some pressing and serious connection delays. Following the engagement with Ergon, we held regional road shows in Cairns, Mackay, Bundaberg, and Townsville. This allowed us to collectively voice our concerns regarding connectivity delays and uncertainty, negatively

impacting our members and their ability to deliver projects and importantly, homebuyers.

Success was also achieved when the Mayor of Toowoomba's Regional Council re-signed the Institute's Memorandum of Understanding (MOU), committing to transparent and accountable interaction with the industry and our members.

Accelerating discussions and actions around the impact population growth and land supply have had on housing affordability and rental availability, has been a key priority this year. This focus will continue into 2023. Support from members has helped to amplify our voice in this important area as we seek a resilient planning system that allows us to bring stock to market.

The Review into the Role of the Property Developer is a topic that the Institute has continued to actively engage with the State. The introduction of any additional licensing or red tape could add significant confusion, inefficiency, and cost to a system already under severe strain. I encourage you to continue engaging with the Institute on this important topic.

The final event for 2022 was the Institute's Awards for Excellence. Once again, this was a wonderful opportunity for over 700 guests to celebrate the innovation in our industry and our leaders. Neil McAlister was recognised for his longstanding support and commitment to the Institute and was granted Life Membership of the Institute. Finally, our judges are to be commended on their time, dedication, and commitment shown in making this event happen.

Rounding out the year, we held our Awards for Excellence as we do every year in November, showcasing our industry's commitment to quality, innovation, and resourcefulness. The entries received were outstanding and reflected the role innovation plays in creating a quality lifestyle in the Sunshine State - one that is continuing to attract people from interstate and beyond. The passion and dedication shown by members act as a catalyst and inspiration for future developments, and year on year, we see projects that are setting the new bar for the industry.


